Credit unions that are participants on the RTP network and/or FedNow Service can choose Corporate One as their partner to manage the 24/7/365 funding requirements. In addition, Corporate One can serve as the funding agent or settlement provider for any credit union using Corporate One as a Third-Party Service Provider (TPSP) or any other TPSP.
